



## LEAP IN THE WORLD

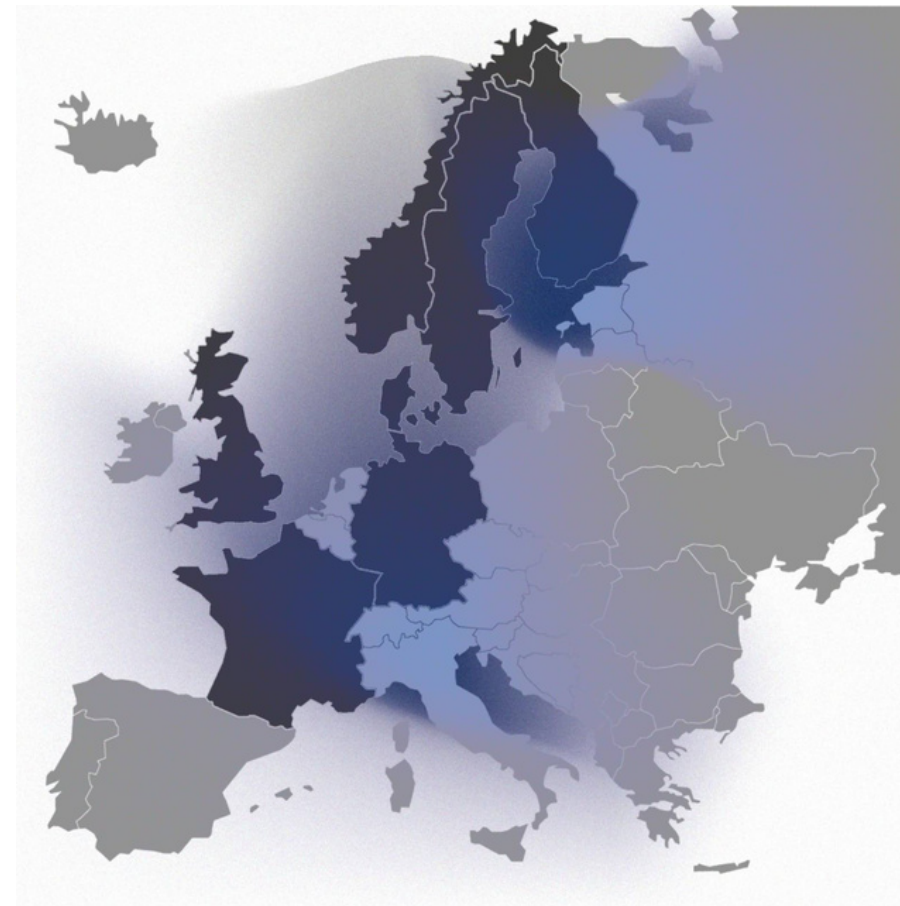
LEAP Europe's members come from the police, justice, army, prison and intelligence forces

## One objective

To improve the safety and public health of Europe's populations through the project of reforming criminal justice



## How can this be done?

By re-establishing a relationship of trust between law & order officers -in particular the police forces- with the greater public, in particular by changing drug policies

- Intervenes with the wider public & political decision-makers on criminal policy reform projects, including drug policies

## PARIS 16/03

LEAP France is organising in Paris an exchange between representatives of different candidates, members of civil society and academics, in view of the French presidential and legislative elections of 2022



## BARCELONA 08/04

Catalan cannabis laws were at the forefront of alternative regulatory models in Europe. A virtuous model now in danger that LEAP will try to support through a public debate



## LONDON OCTOBER 2022

A key voice in the UK drugs policy debate, LEAP UK will bring together cross-party political members within the Houses of Parliament for a trans-partisan debate

LEAP's voice has enabled the Green Party, as a member of the Finnish government coalition, to take a supportive stand for the legal regulation of cannabis

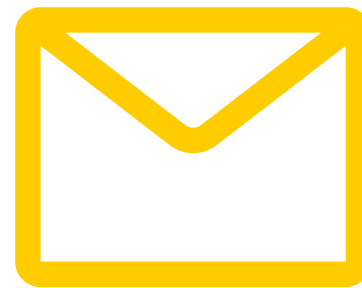
